

Architects of the Future

Freedom or serfdom is now humanity's choice

What is your choice? To live in freedom, respectful of others as your Creator intended, or mercilessly suffer deprivation and harm at the hands of authoritarian psychopaths? That choice, facing all people, grows more urgent by the minute!

Only a minuscule few grasp its crucial importance. Many, if not most, are still asleep. Increasing numbers are baffled yet claim to be awake. Some rightfully question whether their nation's Constitution document should be rewritten.

The answer is absolutely yes! Had any empire, monarchism, socialism, communism, democracy, or republic ever permitted societal freedom, the world would not have plummeted towards destruction as it has. The principle of top-down rule has presided over the world for centuries. No one considers an alternative possible, so no one seeks such a thing.

Psychopathically destructive crime is irrefutably evident over four years past, and though millions, if not billions, seek remedy, precious few ask what caused it. Why are people so blinded? Why do so many spend hours, days, or weeks fussing over chronic symptoms, and no one considers their root cause? There are two reasons—

- 1. French Philosopher Jean Jacques Rousseau said in the mid 1700s. "While freedom is a fact of nature, people should be taught to consider that it is dangerous; whereby they ought to sacrifice their individual nature to the artificial condition of citizenship. Furthermore, natural persons should become artificial persons, that is, citizens —wittingly or unwittingly—willingly, or by legal compulsion." Humanity has never learned the first seven words and has swallowed the remainder hook, line and sinker.
- 2. Until 2017, human consciousness was, and predominantly still is, considered 'awareness' only. Psychologists and neuroscientists freely admit they do not know what consciousness is or how it works. How can you use your precious abilities or avert mental corruption?

Technology has leapt ahead, but knowledge of our mental operating system stagnates in middle-age darkness, putrified by ignorant illusions, presumptions, and erroneous ideologies. Frequency and energy hogwash regularly splash like a lubricant over apathetic people who refuse to seek the truth—because that's for academia. But that outcome, though tragic, is not the worst.

Governments prescribe our actions upfront through statutes and legislation and browbeat our acceptance with terms like the 'rule of law' and 'no one is above the law.' Thus, indoctrinated and cajoled, we fall into line to avoid punishment, whereby our subconscious mind automatically accepts those propagandised values as our preference and emotionally rewards our corresponding actions. The public is brainwashed, thereby mind-controlled without their knowing. As a result, governments are recognised as the benefactors of people's comfort and security. No one, it seems, knows that conscious nescience (ness-see-ence) is the root cause of our slavery to authoritarian rule. As a result, nobody knows what law factually is or has any clue regarding a freedom alternative to government, and that damnable catastrophe is today's crisis.

All who seek a new constitution must adjudicate their findings based on that dark age mental vacancy. Nescience is not the people's fault. No one can act on what was not known. The

remedy is to learn and act on what is now known, not revert to common law, democracy, republicanism, or some other invented pretence.

People must learn that "freedom is a fact of nature" absolutely and that to rule in defiance is a crime against humanity! Only then can they write a NEW Constitution!

Our task is crystal clear. People must learn that 'law' is (intrinsic) natural law (Latin, *ius naturale*) and nothing else. Also, learn the fundamentals of the conscious process and its twenty governing laws bestowed by our Creator. They exist for us to live, thrive, and prosper in free, peaceable societies absent all authoritarian rule, fully protected from all harm and evil. When you learn that intrinsic natural law is not primarily about remedying crime but conclusively about your physical, mental, emotional, and spiritual emancipation, you will have advanced more in two milliseconds than humanity has in two centuries.

The truth is that we all were born into the jurisdiction of life. Those who deny life to structure society on the premise of death, as Rousseau advocated, voluntarily refute their (born) nature, rendering them incompetent to hold any public office. And they need to be told!

Within our conscious process, ethics, morality, individual rights and natural justice unite as one indissoluble framework blessed by your Creator. Your independence and freedom are assured, provided you respect the equal rights of all others to live likewise. Their freedom guarantees yours. All that remains is to protect your rights and freedoms from all trespass, usurpation, coercion, rule and violence. Their focused independence shows an example to all who apathetically abdicate from life and become dependent on others. Sovereign people apply life values such as diligence, discipline, respect, and integrity, all in pursuit of practical, moral, and spiritual thriving. They accept full responsibility and liability for their actions. Every mental and emotional reward signifies success. Skills of personal excellence, spiritual accomplishment, and emotional rewards testify to their advancement. Joy and happiness are their rewards.

Perfection is not demanded. Instead, an exemplary attitude toward life is required: spiritual mindedness resulting in ethical thought, leading to just actions and behaviour, and a decisive willingness to correct errors should they occur. When that process is engaged and upheld, sovereignty emerges. Sovereignty is not automatic. Its status cannot be claimed by default or granted by others since it only exists when self-actualised by living men and women. They set their desires, ambitions, and values on human nature and life, rightfully and lawfully establishing that any challengers must refer their dispute to their Creator.

Peace-loving, organic societies are not only possible, the likes of which the world has never witnessed, but nature impels us to do so. Many sovereign individuals will unite to institute such societies and protect their sovereign rights to life, freedom, and the pursuit of happiness. Logically, no political instrument may deny, control, usurp, brutalise, force, coerce or confiscate anyone's mind, no matter their political, authoritarian, legal, off-world or bloodline claim, period! As our source creator determined, the human mind is inviolate, and our nature permits no excuse or exception.

Humanity now has the solution it yearns for, as described in my books and documents prepared for '*Protectures*' that lawfully replace legal governments. Let's be clear.

The same applies to legal authority, aka government. Every legal, judicial or government official who enacts an unjust, harmful action or crime does so by choice because, as the conscious process shows unequivocally, nothing would have happened had they not chosen. Similarly, all who work to govern your (so-called) strawman, a dead fictional entity bearing your plagiarised name, have voluntarily agreed to uphold a legal regime premised on death. They have chosen to relinquish the state of nature into which they were born – the jurisdiction of life. By so doing, they publicly confess they are unfit to hold public office of any kind, and further, all their statutes and legislations are void. Someone pretending to be a fictional legal entity, absent heart, liver, lungs, or mind, confesses by uttering just one word they are a living being playacting in utter denial of their nature. The more they insist on their legal authority, rank, position or office, the louder their confession. Our human nature is axiomatic—individuals must use it to deny it. Accordingly, all legal pretenders, charlatans and imposters are challenged to defend their authority in 'life' terms, not legal terms, or butt out. No government can deny a Protecture founded on the supremacy of life, or else it denies itself. Neither can any government justify life's protection when founded on the premise of death.

Life's intrinsic protection is an exceedingly powerful and lawful tool no one has previously considered. All who challenge it are doomed to fail. Propaganda, indoctrination, conscious nescience and mind control have, over centuries, infused a common mindset that nothing better can ever exist for man, whereby the best on offer is to re-invigorate the prime source of all ills, namely government or corporate interference causing the people's sufferance or death while profiting all who administer these unspeakable crimes against humanity.
