

“Consent of the governed”?

Have you ever pondered the idea of being born free, with your Creator’s consent to live in freedom shielded from all authoritarian rule and evil? Or do you find comfort in being authoritatively governed under the guise of your consent? This is the choice that humanity is confronted with today, a choice that remains largely unknown to many.

Governments were established to protect people’s rights, not to sow the seeds of discontent and instability that result in crisis. When the egregious actions of abusive governments escalate, corruption, political correctness, censorship, impunity, and violence surge as the most effective means to achieve their goals. Is that really what you want? What if the secret to political freedom was written into your nature, but no one told you so? Would you like to learn more, thus welcoming freedom, peace, and happiness while dispatching evil to history?

Do you want to push back against today’s abuses by upholding and protecting your rights. Will revitalising government assist you, or is authoritarian power the prime source of your suffering? Is there an alternative to abusive rule? Can that alternate deliver a free society and protect it? Can we each be sovereign individuals as Our Creator intended?

Government or Respectful Freedom?

Australia has several (fragmented) freedom movements, which are notably different but ostensibly have the same mission. Most are united by their anger concerning overt government dictates and increasing intrusion in their lives, and the people’s protests are not stopping. Most freedom activists express a complete distrust of government, yet they seem intent on collapsing corporate control to reinstate the very thing that permitted it in the first place. Nevertheless, one person said: “I’m ready to go to jail, I’m ready to go to war, and I’m ready to battle until death and protect my god’s given gift of birth rights.” But is that true? What government has ever protected our born rights over and beyond protecting the survival of its state?

The overarching lesson is that we can only bandage our wounds unless we learn the prime cause of today’s socio/political disaster. What if we knew how our power from Source Creator renders the whole political power scheme redundant? That would raise new questions.

“Why do we have a government?” The answer is because we have been falsely taught that ‘freedom is dangerous’ and therefore we need someone to rule over us. Because nature cannot be governed, the government by-passed it, by creating a legal system with legal entities, often called our “strawman.” This legal entity or ‘person’ is ruled. We are indoctrinated to believe that this fictional entity is ourself, the living man or woman. As

shocking as that is, neuroscience admits it doesn't know how the conscious process works. That mental vacuum greatly intensifies authoritarian power and our pains. We are denied knowing what could wipe out the fraudulent legal system in seconds.

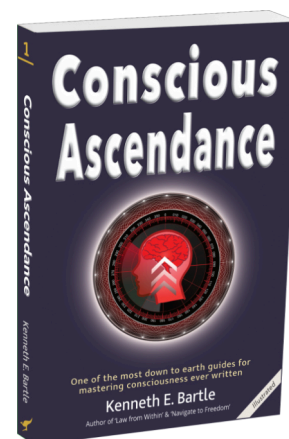
Governments have the power to fund scientific studies, but this also means they can influence and control what areas of science are being studied. As a result, people may need to be made aware of the knowledge and information that they are missing out on. The idea of a government-free society seems unattainable, thus alternatives to top-down rule are never considered. Not surprisingly, the 'freedom movement' fails to consider anything beyond reinstating authoritarian rule in some form.

If there exists an alternative that is more empowering and lawful, would you still be willing to tolerate evil? Many people want to liberate our country from tyrannical villains once and for all. Freedom fighters often say they will not yield, give in or give up. But is such a fight necessary at all? Weren't you born free? Weren't today's criminals born free? Who abandoned the freedom they were born into? Was it you, or was it them? Isn't it true that they must become a fictional strawman to command yours? If so, their legislation is worthless. It's premised on death, not life. You do not have to exit their legal system. They've already departed your lawful system. They reneged on life and freedom to become outlaws. Life is your salvation. Uphold it and leave those who abandoned it to falter without it.

New revelations

What if the word consciousness refers to a life-sustaining process, not a thing? What if that process works in the mental/emotional realm like your biology works in the material realm? What if it is now known how our conscious process works and interfaces with material existence on the one hand and our soul on the other? I'm not kidding. 1. Conscious Ascendance. This book describes the complete conscious process as it relates to the life-sustaining values of your choice. It also explains how infant children can program their subconscious mind without words, math, or science, the source of our feelings and emotions, and how you can conduct the whole orchestra of your mental abilities.



The whole process reveals twenty governing laws that ensure your success. None prescribe your actions in the way that we think the law works. Instead, they adjudicate your actions afterwards. Thus, these laws are your teacher, your mentor in fact. This information allows you to mentally and emotionally excel beyond measure, run your treasured values on autopilot, and banish all fear. These explanations, supported by diagrams, are unavailable elsewhere, save for seven animated videos on my website, naturallawmatters.com.

2. Navigate to Freedom. This book takes *Conscious Ascendance* further by showing how intrinsic natural law at the personal level develops one's ethics, morality and justice. Personal sovereignty emerges from choosing and exercising life values that respect and uphold the rights of all others. Unalienable rights and inalienable rights are discussed in

full. In sum, it is shown how our intrinsic natural laws in personal use translate into society verbatim. No discrepancy exists. All are consented to and backed by our Creator. No one can dispute these laws without refuting their born nature, which naturally denies their dispute.

Whereas the first book describes the twenty natural laws in terms of their origin and personal use, this book explains them in societal terms. Their importance is more robust, more relevant and ever more powerful. Indeed, four hundred years of '*natural law theory*' have been overturned. It is replaced by intrinsic natural law which cannot be erased, or disputed without using it.

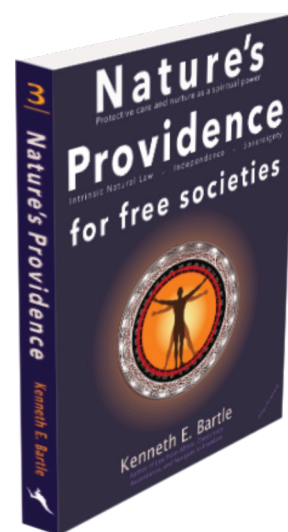
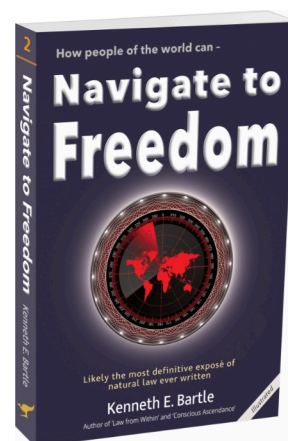
The upshot is that '*common law*,' long held to be the law of men and women as distinct from corporate and admiralty law, is shown to have a factual (natural law) foundation, not a believed foundation. The result is mind-blowing, especially regarding individual rights, peace, harmony and natural justice.

3. Nature's Providence. This book, published twelve months after the two books above, completes the three-book series. It unites the personal aspects of natural law with the socio/political aspects through an objective philosophy. Thus, it becomes a practical textbook describing how natural law is best practised personally and socially. Coincidentally, a union is witnessed between the subconscious process, its twenty governing laws, philosophy, and several tenets that apply to all twenty natural laws. They are described in a philosophical framework this time.

Once this realisation is reached, it becomes evident that no law we've ever practised will suffice. Today's top-down authoritarian rule is over! To quote Thomas Jefferson, "*A nation that expects to be ignorant and free in a state of civilisation expects what never was and never will be.*" Fortunately, the converse is also true. "*A nation that expects to be knowledgeable and free in a state of civilisation expects what should be and protects it.*" The remainder of the book introduces the idea of a 'Protecture' that replaces government. It is a body of people elected to protect the people from all crime and aggression, constitutionally forbidden from making rules. Its sole task is protection, which logically includes lighthouses, airport security, waste disposal, etc. (Read *Architects of the Future*.)

Several matters are of crucial importance

- Self-control leads to self-mastery and, thence personal sovereignty. Sovereignty is individual and can be nothing else.
- The (conscious) Value Transfer Wave reveals twenty intrinsic natural laws no human legislator can rebut or erase. None of them command. All exist to sustain our lives by adjudicating the consequences of our actions, which is how natural law translates to natural justice for juries or Justices.
- Life values that uphold and sustain life are the bottom line. They, with intrinsic natural law, determine ethics, morality and justice.

- Accordingly, the Creators' model for free symbiotic societies has been rooted in human nature despite not being known until its first presentation in 2017.
- The "*natural law of no trespass*" is founded on the intrinsic factual principle at the heart of the conscious process: "*No mind can rule another.*" This principle abolishes all authoritarian states and legislation falsely called law. It overwrites the Non-Aggression Principle (NAP), multiplying its veracity and establishing it as fact.
- As a result, well-known '*common law*' now has a natural law foundation authored by our Source Creator, one it has always had but no one ever knew. Common law may be retired, entirely replaced by irrefutable *intrinsic natural law*, common to everyone.
- "*Consent of the governed*" is also now redundant. No government exists. The Creator's consent for the people to be protected is absolute; thus, "*Creator's consent*" replaces that obsolete phrase.

Vital questions

The beauty is that no one has to wait for political freedom to begin practising natural law. It exists within us already, and you can start today. All we need to do is learn of it and use it daily. The more we do, the more brilliant light shines in the world, and darkness is defeated. The more we profit, the greater our resolve to protect our freedom to thrive. The more we develop freedom, the less tyrants can rule us without refuting their (born) nature, rendering all their disputes worthless. We are all blessed with a win-win fact of life that no authoritarian can dispute or erase.

What if natural laws were addressed as if common law? Would millions say yes? If people grasped that natural law surpassed common law as factual and not some reasoned theory, would millions more say yes? What if a body resembling a government never governed anyone but protected their rights and freedoms instead? Would people say yes? Or would they demand their rights be trodden in the dust, their freedoms curtailed, and their lives made subject to some unelected offshore dictator? What if we had our Creator's consent to self-govern and to protect ourselves from all evil, tyrants and dictators? And what if those authoritarian's refusal to honour their born rights to scorch ours was, in fact, a crime itself?

What could be simpler than a Protecture that upholds the peace and people's right to live as they choose, both of which uphold other people's right to do the same? What if that '*Protecture*' had all the public services the people now have, but all dictatorial rule was forbidden? What if the people mastered their own lives within the rights of all others and their elected (*Protecture*) members were their servants, as Common law has long suggested?

Suppose that ethics and morality come from what is within us, not the Church or the State. And what if natural law, believed to uphold common law, was not a theory but turned out to be factual and far more powerful? Would common law survive, or would natural law render it redundant?

Would you agree to your offspring having unswerving protection from pedophiles and child traffickers? Would you agree to be protected from bioweapons, burdensome taxes, corrupted schools, financial tyranny and theft of your private data, all blessed and backed to the hilt by your Creator? Would the people you love go for such things? Or would they say, "Aah, forget it – who won the footy last night?"

In the future

Do you see how what you've learned in just three pages far exceeds anything the world has ever witnessed? Can you imagine a body that looks like a government but is vastly less because it only protects and never makes legislation? It has no upper or lower house and no parliament. No taxes apply, nor any registration that seizes ownership of one's property. No land taxes or excise duties apply, and no victimless crimes exist.

Whereas any nation may create infinite amounts of currency, an infinite amount of value cannot be created. Currency is protected by regulating its value. Currency is a representation of value; the prerequisite, therefore, is the creation of value. Thus, no currency may be created without the corresponding creation of value. Divergence from a one-to-one ratio (1:1) of currency to value represents either inflation, where currency exceeds value, or deflation, where value exceeds currency.



You elect your protectors at the state, national, and local county levels, and their sole task is your protection. Individual rights are the unalienable right to life and your inalienable property right, and they ensure it.

Do you think new education is imperative? People will have to revise many textbooks based on this new knowledge, and school curricula must be rewritten to coincide with the morality revealed by intrinsic natural law. A new biometric ID system is already in operation. It is a private ID, bank number, and car number plate that can be identical for up to nine cars. All are your private property. None of them will be registered but are recorded for theft recovery if needed. This ID system may eventually replace passports.

Of course, many people will wonder what additional efforts they must make to live in a free and symbiotic society. The answer is much less than the efforts they spend upholding the government today through crippling taxation.

Those who have already mastered their lives will have a significant advantage. Others may have to re-evaluate their efforts, while bludgers and parasites will be in for a shock. However, even they will have a flying start with no taxes or other financial penalties. I have listed one hundred and twenty-four benefits that apply overall. But when people begin living a valued-based life as they should, many more benefits will emerge in ways only a free society can produce.

Evil will continue to worsen if what I've described does not happen. Today's disastrous mess happened precisely because every monarchy, communism, socialism, democracy, empire, or majority rule failed dismally. All because people were never taught that "*No mind can rule another,*" as the Source Creator has written into our nature. That tragedy was blithely upheld by science because it never discovered the factual proof that "***No mind can rule another.***"

Today's remedy is straightforward

You bet it is! Our task is to learn from nature, apply its lessons, and never turn back. My books tell the story. Our Creator has bestowed freedom and protection on us all. All who refuse it refute their born nature, thus rendering their dispute worthless. Those who step outside natural law are outlaws by choice. Our nature is not open for opined debate, nor are its governing laws.

Not everyone will respond affirmatively to this news, of course, and that is fine. But what if families, work colleagues, or neighbours are seen to profit handsomely from exercising the conscious process as our Creator intended? What if more and more people notice precisely how personal benefits fit society to perfection?

And what if those leaders became the founders of a new society never witnessed in history as the Americans did in 1776 with their Declaration of Independence? What if these leaders brought their academic abilities into the sunlight to write a new Constitution based on these intrinsic natural law principles? What if a Charter of Individual Rights pulled it all together?
