The People's Choice Rule or Freedom?



umanity has reached a crossroads concerning its future or its extinction.

Some people choose to rule others, which, they argue, is imperative for a society to

function. Nature cannot be ruled, however. For that reason, sociopaths chose to invent a 'Strawman.' This fictional fraudulent entity legally substitutes for independent men and women. And that legality underpins Admiralty and Maritime law, in which living men and women are not recognised. The people's born rights are rejected, and so is intrinsic natural law bestowed by our Source Creator, all in favour of legal statutes that reject our right to life.

This curse results from psychologists, neuroscience and humanity not knowing what consciousness is or how it works. None know that it reveals twenty natural laws for the people's most significant benefit. No one recognises how our conscious process teaches that '*no mind can rule another*', manifestly denying all authoritarian rule without exception. Additionally, these revelations overturn natural law theory – the purported foundation of Common law.

None of these natural laws rules, prescribes, or commands our behaviour. All of them adjudicate the consequences of our actions after we have acted. Those facts of life uphold our born rights, wholly determined by Source Creator. They cannot be altered or erased. Any attempt to overrule them denies one's life, instantly invalidating the attempt, which explains why legality is premised on death.

The jurisdiction of Life

The truth is that all people are born into the jurisdiction of life, and there are no exceptions. Those who rule us voluntarily chose to vacate life's jurisdiction. They've abandoned their lives to rule ours. We do not need to withdraw from their invented *legal* jurisdiction. They've already departed our *life* jurisdiction—into which they were born.

"Those who step outside natural laws are outlaws" — Frank van Dun, philosopher of law.

Humanity faces an evident choice. It can choose to maintain authoritarian rule and suffer. Or, people can each govern themselves and protect their (born) right to live freely. Either we choose rights, natural justice, and (respectful) freedom, or we continue submitting to today's invented statutes, legislation, tax theft, oppression, tyranny, and slavery.

If we choose freedom, we must protect our rights from all who refuse, usurp, overrule, or deny us. Without such protection, authoritarian rulers, sociopaths, criminals and tyrants have free licence to cripple humanity for their benefit.

If government is our choice, then we must recognise it is man-made. Accordingly, people are entitled to have their say. Hence, opinions, debates, votes, referendums, upper and lower houses, legislation, statutes, law enforcement officers, and other trappings are required just as before.

If freedom is to be instituted conversely, individual governance of one's self assumes prominence. No communal or majority votes are needed since our source Creator's consent is indisputably intrinsic in our born nature and cannot be altered. Only tyrants intent on dictatorial or criminal activity can disagree or object to you and me exercising our born freedom within the equal rights of all others. Our freedom is bestowed by the source Creator; thus, protecting our right to life takes precedence. No need exists to invent laws. Meanwhile, education becomes paramount.

Protectures

The word 'Protecture' was last used in the 1500's. I've restored it to define a body elected by the people solely to protect their rights and freedoms. As a result, the government is left to wither and die. My brief Protecture proposals follow, otherwise fully described in my Constitution and Charter of Individual Rights.

State and National Protectures replace governments. Local councils or counties serve local issues. All are elected by the people.

The sole task of Protectures is protection in all its forms, including but not limited to people's rights, freedoms, property, and public assets such as coastal lighthouses, navigation radar, etc.

The 'Constitution for Terra Australis' offers the following-

- All roles, official office structures, functions and election procedures are defined.
- No upper and lower houses, parliament, political parties, legislations, or statutes exist.
- No land or waterways are owned; all are subject to custodial title. Hence, no land can be sold or bought by anyone, foreign or domestic.
- Infrastructures built on the land are private property that can be bought and sold, with custodial title and infrastructures changing hands but not land ownership.

- No national debt exists. All banks are private.
- No taxes of any kind apply.
- Treasury funding is assured. No inflation or deflation is possible.
- Police, border protection, the judiciary and military are retained, all subject to intrinsic natural law without exception.
- Living men and women are recognised. Legal entities are abolished.
- Unalienable and inalienable rights are negatively specified, meaning they cannot be denied or removed.
- People have the right to bear arms within intrinsic natural law protocols.
- Data collection is permitted, but since all is private property, all sales without permission or hacking is a crime.
- No government data collection is possible since no government exists.
- Unalienable and inalienable rights to life and property are outlined in the Constitution. All trespass is a crime.
- Registrations no longer apply. Recording applies to custodial land titles, private, business and Protecture cars and vehicles. State and national recording offices are defined.
- State and national highways are funded by the Treasury. Small local roads are funded by the local people.
- National and State Facilitation Centres (NFC and SFC) are established. Subject to defined rules that protect the people, these centres exist to protect the people, fundamentally but not limited to erecting public infrastructures and creating public assets such as libraries, art galleries, etc., as well as national and state roads, airports, hospitals, and more. Town planning and building standards are also accommodated.
- Any abrogation or trespass of the Constitution by a Protecture instantly collapses that Protecture; all rights retained by the people.

Life is the benchmark

In fundamental terms, the people and their lives are the bottom line. They employ all Protecture members, even the President. There is no top-down rule whatsoever. Instead, there is freedom from the bottom up, all protected. Trespassers and criminals are outlaws of their own volition; hence, all restitution or recompense penalties result from their choice to harm others. No judge should rule against them since they have already ruled against themselves. The exact same applies to all sociopaths who presently dominate and control the populace.

Of crucial importance, no natural laws directly address government, legislation, legality, law courts, politics, media, transport, energy, taxation, real estate, motor vehicles, shipping, airports, clothing, food production, or gender issues. However, all those matters are addressed indirectly because all concerns are independent human life and the education of individuals. As van Dun clarifies, *"law is natural law and nothing else."*

Additionally, I have written a 'Declaration of Independence' for Australians. My 'Biometric ID system', conceived in 2013, was computerised by a colleague in America and has been used there for the last two years by American State Nationals.
